# Thursday, July 27th at 5:30 PM Prospect Mountain Ski Area Base Lodge 204 Prospect Access Road Woodford, VT


A light meal will be provided.

# **New HOME Act Summary Available**

BCRC prepared a quick reference guide to the wide-ranging provisions of the HOME Act (Act 47) passed by the legislature and signed by Governor Scott in June. This guide will be useful to local officials (including zoning administrators, planning commissions and DRBs and ZBAs) working to understand how to comply with new laws and how to access new programs designed to remove barriers to housing in their communities.

The BCRC guide includes references to sections of the HOME Act that will need to be consulted for a full understanding of its various provisions, as well as references to relevant sections in state statute. This is important because many of the provisions went into effect on July 1, 2023, although the Vermont Statutes Online will not be updated with the new language until October.

# Benn High Redevelopment Project Health Impact Assessment Now Available

The Bennington Office of Local Health has recently completed a comprehensive Health Impact Assessment (HIA) of the Benn High Redevelopment Project in downtown Bennington. An HIA is a process that uses various types of data, analytical methods, and stakeholder input to determine the potential effects of a proposed project on the health of a population. The Benn High HIA was conducted to better understand the potential health effects of the redevelopment of the old Bennington High School (currently a vacant building), into housing and community space. Community engagement was an important part of the HIA process; a survey was distributed to residents of the Benn High neighborhood, and a series of forums were held with youth and seniors who stand to be impacted by the project. The HIA process was led by a steering committee with representatives from the Bennington



The sixth Southern Vermont Economy Summit brought nearly three hundred people to the Hermitage in Wilmington for a day of learning, networking and celebration of those who dedicated to making the regional economy stronger and improving the lives of those living here. The event is produced annually by Brattleboro Development Credit Corporation and the BCRC.

# **New Funding for EV Charging Available!**

The Agency of Commerce and Community Development (ACCD) has contracted with Green Mountain Power (GMP) to administer a new round of the Electric Vehicle Supply Equipment Grant Program. The most recent round of funding in 2021 allocated \$1 million to EV charging at multi-unit dwelling affordable housing properties across the state. Under this round, Shires Housing was awarded \$85,000 to install EV chargers at three of their properties in Bennington and Arlington. Preapplications for the new round of funding are now available! This new round will allocate \$3 million to charging at multi-unit properties (priority given to properties with less 20 units), \$2 million to workplace charging (priority given to employers with fewer than 100 employees), and \$2 million to EV charging at public attractions. Municipalities that are interested in supporting EV charging in their community can do so through the adoption of <u>EVSE-friendly development regulations</u>. Businesses, nonprofits, and public entities that are interested in hosting EV charging at their location, as well as EV service providers, are encouraged to <u>complete a survey</u> to help the state gauge interest and capacity for EV charging.

# New Household Hazardous Waste Facility Opens July 31st

The new Permanent Household Hazardous Waste Collection Facility is nearly complete and we are accepting appointments for residents and small businesses to drop off material!

The new facility, located at the Bennington Transfer Station (904 Houghton Lane in Bennington), and will be open each week on Mondays (Tuesdays following holiday weekends) starting July 31st until early October.

Residents within the 13-member towns of the Alliance can make appointments online at <a href="https://docs.org/bcs.20">bcswa.org</a> or by calling (802) 442-0713, ext. 2. The cost for residents is \$5.00 per car, per appointment with the fee will collected at the time the appointment is made online, or in-person at the Alliance office at 210 South Street, Suite 6, Bennington, prior to the appointment date.

Small businesses, schools, and other Very Small Quantity Generators (VSQGs) should contact the Alliance office directly at (802) 442-0713, ext. 2 to schedule an appointment and arrange to pay fees charged by the hauler. Material will only be accepted at the facility from individuals who have a scheduled appointment.

In addition to the new facility, several local transfer stations and local retail establishments will continue to accept paint, fluorescent bulbs, used motor oil, computers and electronic waste, batteries and other materials banned from landfills. # Submit a CEDS Project by September 8th!

A September 8th deadline has been announced for the annual submission of projects to be included in the 2019-2024 Southern Vermont Comprehensive Economic Development Strategy (CEDS). Any private or public entity directly responsible for implementation of a project in Southern Vermont is encouraged to submit a project for consideration. A project submission form, CEDS documents, and lists of past projects can be found at <a href="https://www.sovermontzone.com">www.sovermontzone.com</a>. At that website, prospective project submitters can also register for a lunchtime webinar taking place on July 11, 2023 at 12 pm.

The Southern Vermont CEDS, developed through a rigorous public engagement process, is a federally-approved five-year action plan for growing the region's economy. Each year the CEDS is refreshed with the submission of new and updated "CEDS Projects." These projects represent projects, programs and activities – both in progress and in the planning stages – that enhance the region's economic competitiveness and vibrancy.

Following the close of the annual submission period, project submissions are reviewed and ranked by a committee of volunteers from across the region. The ranking process considers how each project will advance CEDS objectives, as well as readiness to begin, partners, and funding. While the inclusion of a project in the CEDS update does not guarantee future investment, it does indicate to federal, state and philanthropic funders that a project aligns with regional goals and plans.

#### **Community Recovery & Revitalization Program Grants**

CRRP grants are available to for-profit, nonprofit, and municipal applicants. The funding is intended for projects making capital improvements or capital expansions that spur economic recovery and revitalization in communities across the state. Eligible projects may include those that assist industries most impacted by the COVID-19 pandemic such as arts and entertainment, hospitality, agriculture, and educational services. The funding is also available for capital expenditures that support childcare and affordable housing opportunities for low- and moderate-income households, and to establish or improve municipal water and wastewater systems to build housing or create jobs through business creation and expansion. Projects must show a COVID impact.
